**FINANCE**

**29/19 S106 Funding.** Abigail Brown, Public Art Specialist, VWHDC attended the meeting to explain how the S106 funding from development P15/V0271/O land at Kings Lane can be spent. The amount of £4,933.53 must be spent on the provision of public art within the parish such as: stone, wood or metal carving, lighting, seating, railings, fencing, paving, flooring etc. As the amount of S106 funding is under £5,000 there is no need to obtain 3 quotes, no planning permission is needed if the public art is under 2m tall and resident artists can be commissioned to produce the public art. Additional funding could be sourced from the Arts Development Fund if required. The Chairman would arrange a meeting with local artists for thoughts and ideas and report back at the next Council meeting. The Council thanked Abigail for her time.

**31/19 Update on other current matters.** Council objected to planning application P18/V2996/FUL Eyre, Mallins Lane, Longcot - demolition of existing dwelling and replacement with 2 x dwellings on the grounds that no drainage plan had been submitted. The Chairman had received a proposed indicative drainage layout plan to dispose of surface water from all proposed impermeable from Leigh Travers, Flood Risk and Drainage Engineer, VWHDC. Council discussed the proposal and agreed to approve the drainage plan along with the following comments:

- as the drainage plan is based on a swale and pond that is not on the property of the actual planning application, that access is always given to maintain this drainage facility and that if the field is ever sold that there is protection over the maintenance and existence of this drainage facility.
