I will be asking (again) that OCC prioritise repairs to the dangerous potholes on the A420 around Acorn Bridge, and to investigate drainage of the constant flood on the eastbound lane in the dip between the B4508 Highworth Road junction and Cross Trees roundabout.

Buscot Wick Flooding – Environment Agency and OCC response

Kat has been supporting Cllr Thomas, OCC councillor for Faringdon ward, to get information from the Environment Agency about their understanding of repeated flooding in Buscot Wick. The Environment Agency have now responded, and Cllr Thomas will share the information with residents and parish councils.

Council News Vale District Council Budget

Given local authority finances nationally, we are pleased to know that Vale's finances are in relatively good shape. The budget included a further two years of funding for the community hub, which supports residents with cost of living, housing, and wellbeing. We were disappointed – given what we considered a lack of focus on climate and environment in the budget – that our modest proposal to include additional funding for the Climate Action Fund to meet demand was rejected by the Liberal Democrat group.

Garden Waste Bin Permit Scheme

Vale of White Horse District Council is introducing a garden waste permit scheme from April 2025. Customers will receive a sticker permit for their bins to identify them as fully paid-up garden waste customers. All existing customers will need to subscribe to the new permit payment system. Existing customers will be notified directly, with full information on the council websites and each house getting a bin hanger flagging the changes. The payment year will run from 1 April to 31 March each year.

The council is asking all renewals to be made online where possible, as they expect phone lines to be very busy.

We have received lots of queries about why there is no longer an option to pay by direct debit. Part of reason for this decision is the high rate of direct debit failure, and the amount of resource needed to chase these up. It is hoped that this system will be a fairer way to ensure that the waste teams know who has paid for green waste collections.

Housing Allocations Policy Review

South Oxfordshire and Vale of White Horse District Councils are seeking residents' views on proposed changes to their joint Housing Allocations Policy.

The councils maintain a housing register and advertise available social housing through a Choice Based Lettings Scheme. The Joint Housing Allocations Policy sets out the criteria to join the housing register and the rules for how social housing is allocated. The policy needs updating to reflect current housing priorities in the districts and a consultation is open until Tuesday 18 March 2025.
